# Preface to Building Plaque Application for 132 N. Channing Street, Elgin, Illinois 60120

#### Statement of Value

This residence was designed in the Italinate style. It shows many of the features typically found on modest residential buildings constructed of this type. These include: 1) Tall, narrow windows with one over one sashes, 2) Decorative scroll work above the porches, 3) Square porch columns and newel posts with chamfered sides. 4) A diamond shaped, colored glass windows in the main staircase hallway.

## **Building Alterations**

The Gifford Park Association attempted to make a faithful restoration of the building to its original appearance. The porches were reconstructed and the trim details that had been removed were replaced. Lacking, photographs of the original building, the design of these elements was based on "shadows" found during reconstruction and details taken from homes of similar age and style. Sanborn maps reveal that there was once a bay window on the south elevation. This feature was not reconstructed.

The interior room lay out remain largely unchanged with these exceptions: 1) A door from the kitchen to the south porch was closed off to allow for more counter and cabinet space inside the home. The appearance of a door was maintained on the exterior. 2) A pantry off the kitchen had been converted into a toilet, (the sink and shower had been installed in the front foyer). The toilet opened into the kitchen. During the Gifford Park Association rehabilitation of the property the kitchen/toilet doorway was closed off and a new opening created into what became known as the library. A small sink was added, necessitating a bump out into the library. The sink and shower in the foyer had was removed and that area restored to its original appearance. 3) The second floor apartment had the bath and kitchen in rooms on west end of the building. The bath was approximately 6' x 6', the kitchen approximately 10' x 12'. The wall between these rooms was removed and bath enlarged. The former kitchen area became a laundry room.

#### **Additional Historical Notes**

The Gifford Park Association purchased the property in January 2004. The building was one of approximately two dozen looked at for possible purchase and renovation. The home had been clad in a green colored tar paper and aggregate material, similar to rolled roofing material. This has been applied to the sides of the home. At the time the home was two units. It was restored to a single family home. The City of Elgin provided financial assistance through the architectural rehabilitation grant program.

# The History of 132 N. Channing Street

The history of 132 N. Channing Street, Elgin, IL begins with Thomas Mackey.

On June 9, 1882, Mackey purchased Lot 2 and the southerly 10.5 feet of Lot 1 of Block 1 in the Hinsdell Addition to the City of Elgin from E. Norton Miller, who was acting as executor to the last Will and Testament of Jonathan Hinsdell, deceased. Miller was Hinsdell's son-in-law by virtue of his marriage to Hinsdell's daughter, Martha, and part legal owner of the property as part heir to the estate. Mackey pays \$490.53 for the property; an amount that was recorded both with the county and in a Account Ford Miller maintained for the estate.

It is apparent from the price Mackey paid for the property and real estate values of the times, the property was undeveloped at the time of purchase. In either the latter half of 1882 or in 1883, Mackey built a house on the property. According to city and county directories published between 1884 and 1892 indicate the house carried the address of 80 N. Channing Street. In 1894 Elgin reassigned house numbers throughout the city and Mackey's residence became 132 N. Channing, the address it retains today.

Thomas F. Mackey was born to William and Jane Mackey in New York City on March 13, 1854. The family moved to Elgin in 1858, where early city directories indicate William was employed as a laborer. Directories published between 1884 and 1892 indicate Thomas was a contractor and builder and as such was responsible for construction and improvements on a number of homes throughout Elgin. It is quite reasonable to assume he built his home on N. Channing Street. Building permits published in a local newspaper in 1892 indicate he performed carpentry work totaling \$6500 on the home of G. B. Richardson on Chicago Street. City directories for the early 1900s indicate Mackey was by then a city inspector. He is credited with construction and improvements on a number of Elgin homes including that of G. B Richardson on Chicago Street. Building permits published in a local newspaper in 1892 indicate Mackey performed carpentry work totaling \$6500 for Richardson that year. City directories for the early 1900s indicate he was a city inspector residing in Elgin a number of years before moving to Chicago where he died on January 12, 1916. He is buried in Elgin's Bluff City Cemetery.

Before Mackey, E. Norton Miller, and the Hinsdell Addition, the property that is today 132 N. Channing Street was once part of a much larger tract owned by Burgess Truesdell. Land Tract Records from the Division of Public Domain Sales listed with the State of Illinois Archives show Truesdell received a federal deed for 79.97 acres of the east half of the northwest quarter of Township 41N, Range 8E, Section 13 on February 6, 1843. He paid \$1.25 per acre or \$99.96 for the property.

Burgess Truesdell was born to Jonah and Lucy Spink Truesdell on July 23, 1800, in Hillsdale, New York. He came to Elgin in 1838 and gained considerable reputation as one of Elgin's earliest horticulturalists. He established one of the first factories in Elgin, if not the first, where he manufactured silk from silk worms that he raised. Despite producing large quantities of what came to be know as Elgin Silk, the enterprise was never profitable enough to maintain the factory and it eventually closed. Truesdell helped establish Elgin Academy, was one of the first trustees of the First Methodist Church, and was one of the first to promote the development of Trout Park. He died on April 1, 1868, and is buried in Bluff City Cemetery.

By 1848 part of that east half of the northwest quarter that Truesdell purchased in 1843 is owned by Joseph Phelps although it is unclear from records exactly when and how that transfer occurred. On December 11, 1848, Phelps sold that land to Luther Stiles and Cornelius Stiles for \$800.

Joseph Phelps was born in 1769 and settled in Elgin sometime before 1857. The city directory for that year lists a J. E. Phelps as one of ten businessmen who operate grocery stores in town. He died on May 9, 1852, and is buried in Bluff City Cemetery.

Luther Stiles was born on July 9, 1779, in Worcester, Massachusetts. Married to Clarissa Peirce, also of Massachusetts, he arrived in Elgin sometime around 1839. A builder by trade Luther died on June 13, 1857, and is buried in Bluff City Cemetery.

Little is known of Cornelius Stiles. The 1859 city directory lists him as being a carpenter and living on Crosby Street, which is on Elgin's west side near present-day St. Edward High School.

On November 26, 1853, Luther and Cornelius Stiles sell a 5.91 acre portion of the property they purchased from Phelps in 1848 to Jacob W. Brewster for \$1400.

Jacob Brewster is a respected member of the Fox River Valley Settlers succeeding John R. McLean, who founded the organization. In 1850 he is elected the first town supervisor to represent Elgin on the County Board, which was formed the year before when Kane County adopted the township form of local government. The 1859 city directory lists as a mail agent residing on North Street at the corner of Gifford that year.

On November 12, 1864, Brewster sells the property to Jonathan Hinsdell for \$3500.

Jonathan Hinsdell was born March 13, 1791. He was a veteran of the War of 1812 and twice married. He and his first wife, Sally Lott, had a number of children though only Lucetta, Martha, Charlotte, and David survived to adulthood. He was then married to Levyna with whom he had five more children; Eunice, Sarah, Robert, Mary Ann, and George. A daughter Sarah died in 1847, a few weeks prior to her third birthday. Jonathan died on March 25, 1875 and is buried in West Dundee Township Cemetery, Dundee, Illinois.

After his death his heirs had the property he purchased from Brewster in 1864 surveyed, sectioned into blocks and lots, and added to the city on July 15, 1881.

On May 15, 1884, Thomas Mackey bought the remainder of Lot 1 in Block 1 of the Hinsdell Addition for \$500.

On January 22, 1895, Mackey sold Lot 1 in Block 1 of the Hinsdell Addition along with the northerly 6 feet of Lot 2 in the same block to Ezra Rue for \$2700.

A December 19, 1891 issue of the Elgin's *Daily Courier* indicates T. F. Mackey was issued a building permit for \$1950 for construction on N. Channing Street that year. It is assumed from the amount of the building permit and the difference in price between the 1884 and 1895 sales Mackey constructed a house on the property and it is this house that is known today as 140 N. Channing Street.

When Mackey sold Lot 1 and the southerly 6 feet of Lot 2 to Rue in 1895 he retained the southerly 60 feet of Lot 2 or 132 N. Channing Street as his and sold it to Jennie McCornack on April 15, 1896, for \$3262.50. Jennie included her husband, John C. McCornack, on the deed in a separate transaction the following year.

John C. McCornack was first employed with the Cook Publishing Company, which established itself in 1882, and after 1911 with the Brethren Publishing Company, which relocated to Elgin from Mt. Morris, Illinois, in 1899.

John and Jennie McCornack owned 132 N. Channing Street though they did not reside at it. Apparently they rented it to Willis Hauser, a railroad conductor, and his wife, Rose, who were listed at the address between 1896 and 1903. The 1905 city directory is the first directory listing Jennie and John McCornack at the address.

In a Petition for Letters of Administration dated June 10, 1924, Abbie McCornack attested that she and her sisters Ethel and Jessie are the daughters of John McCornack and that he died on June 5, 1924, and in a Matter of Heirship filed February 25, 1925, she further attested that she and her sisters are also the daughters of Jennie McCornack and that she preceded him in death on October 29, 1917, which left herself and her sisters heirs to their parents estate which included 132 N. Channing Street.

On January 29, 1925, Abbie, Ethel, and Jessie sold 132 N. Channing Street to Mike Sanny.

Sanny, or Szanyi as it is spelled in directory listings, was an employee of the gas company. According to the 1925 city directory he and his wife, Mary, resided at 132 N. Channing as did Anton Miller, an employee of the watch factory, and his wife, also named Mary. It would, then, appear the residence was no longer a single family dwelling, but rather a 2-flat.

On September 16, 1926, Sanny, or Szanyi, sold 132 N. Channing Street to Mary McHugh. It appears from directory listings she held the property exclusively as rental real estate having never actually resided at it. A number of residents including Andrew Christopher, driver for Sanitary Milk Co., and his wife, Mabel; James V. Johnston, lino operator with Courier News, and his wife, Rose; Miss Carrie Johnston, an employee of the clock company; Howard Young, who is employed in Oak Park; and his wife, Rose; Sam Wishon, a driver who delivers coal for E. C. Meyer, and his wife, Gladys; Martin Maves, an employee of Elgin Wholesale Oil Company, and his wife, Florence; Howard R. Young and his wife, Rose; and Arthur J. Carlson, an employee of Collingbourne, and his wife, Edna, are listed over the years in directories as residents.

On October 24, 1934, McHugh sold the property to Kenneth Montgomery who also apparently held the property exclusively as rental real estate as there is no record of his having resided at it either.

November 27, 1935, Montgomery sold the property to Crosby Realty, who again apparently held the property exclusively as rental real estate with, according to directory listings, George VanKirk, an employee of Woodruff and Edwards, and his wife, Minnie; Mrs. Doris Millikan; Frank McInturff, employed with the state hospital, and his wife, Myrtle; and Henry Kerber, employed with Delmonica, and his wife, Opal, having resided on the property over the next few years.

On November 1, 1927 Crosby Realty sold 132 N. Channing Street to Frank Albright.

Albright was employed over the years with McGraw Farm, Helm Brothers, and Elgin Machine. He and his wife, Elizabeth, continued the pattern established by former owners of holding the property as rental real estate without living in it for the first two years they owned it. Then in 1939 Frank and Elizabeth took up residence at 132 N. Channing Street.

While they resided on the property the Albrights continued to partially use the property as rental real estate renting over the years first to August Pizzaro and later to Mary Baylis.

By 1951 the Albrights were no longer residents at 132 N. Channing Street although they continue to hold title to it. Apparently they have resorted to the pattern established by previous owners of using it exclusively as rental real estate and residing somewhere else.

City directories between 1951 and 2001 indicate a host of residents at 132 N. Channing Street including; Richard Hinkle, a billing clerk for W & E, and his wife, Linda; Merle Austin, manager of Rockford Life Insurance, and his wife, Hattie; Peter Wicklein, sales manager for Elgin Motor Company, and his wife, Elsie; David Coffman, a clerk at Elgin Paper, and his wife, Donna; Dorothy Winkler, a telephone operator; Scott Eversole, a surveyor for Ticon Engineering, and his wife, Nancy; and James Marquis, factory worker with Elgin Metal Casket Company, and his wife, Lorraine. Melvin Whisenhunt, who held a number of factory jobs, and his wife, Mary, are two of the longest residents living at 132 N. Channing Street between 1967 and 1976.

A Probate Inventory for Elizabeth Albright dated March 17, 1967 listed her as the legal owner of 132 N. Channing Street at the time of her death.

On January 4, 2001 an Affidavit of Heirship filed by Earl Teets, Jr. reaffirmed she owned the property at the time of her death and that he was now legal owner as her heir. It passed to him through his mother, Elizabeth M. Albright Teets, who was the only daughter of Frank and Elizabeth Albright. She died on January 12, 1979 along with her husband, Earl Teets, Sr., and her only other son, Gary Teets, that day. Newspaper accounts in Daily Courier-News indicate the Teets family were found dead in their home in an apparent triple murder.

That same day he filed the Affidavit of Heirship, January 4, 2001, Earl, Jr. sold 132 N. Channing Street to Erika K. Martinez. The following year she included her husband Juan Victor Martinez on the deed and together they sold it to the Gifford Park Association on January 14, 2004.

Today the Gifford Park Association continues to hold the deed to 132 N. Channing; a 2story, wood-framed structure done in the Italianate style of architecture that was popular for the time period in which it was built. It has 3 bedrooms, a walnut staircase in the foyer, a carved marble fireplace in the parlor, and a diamond-shaped leaded glass transom window in the dining room. The garage and shed that appeared on the south and rear of the property in the 1899 and 1913 Sanborn fire maps are gone as is the shed that appeared on the north and rear of the property in the 1939 map. Gone also is the full front porch that appeared on the 1899 map. It was replaced by a smaller porch or stoop as indicated on 1939 map. A bayed window that appeared on the south side of the house in the 1899 also seems to have disappeared from the house. The small back porch on the south and to the rear of the house on the 1899 map appears to have been extended a few feet west by the time of the 1913 map. Over the years a modern kitchen, an upstairs full-bath and full laundry, a downstairs half-bath, and a new furnace have been added. The exterior is scheduled to be fully restored and painted with a historically accurate paint scheme and the two porches will be authentically replicated, all part of the extensive renovation the association plans as part of its mission to save distressed properties in prominent areas of the Gifford Park Historic District and convert them to single family use.
